**Supervisors Requests**

Mr. Greenstein: I would like to have Alan give us an update on how we are proceeding with the new monument.

Mr. Scheerer: I reached out originally to UCC Group, Graham Duffy, Graham was one of the original installers of the monuments and he has gone through about 13 years of archives to see if he can locate the original plans and at this time he doesn't have anything. He is going to try to work backwards to come up with a number for the monuments and George also connected me with a gentleman that had some relationship here back in those days with the monuments and he is visiting the site this week with a company called Florida Wall Concepts and try to work backwards to give us a cost to replicate the monuments that are here. As you know we have marble finials and some decorative items on these monuments as well as the marble etched signage for each community and one of the things I'm told we are going to need, which is why we are going through UCC Group, is a plan the engineer can sign off that we can submit for permit for all these locations. If we can't locate any of that then we are probably going to have to start from scratch.

Mr. Flint: Luke Minton is with Poblocki now, he was with a different company that was the original designer of the signage but UCC Group constructed it. Unfortunately, he no longer has the drawings, the company that bought the company he was with disposed of the archived records. We are still working on it and hopefully, we will have something for you next month.

Mr. Greenstein: The area around the Bears Den is looking fantastic and I think it is going to exceed the expectations of most residents. I noticed that DeBartolo is moving forward with site prep and filling of the apartments on Sinclair in connection with the requisite landscaping that would occur along that property. I know this is something the community has asked for but we will see what the price is. I would like to consider down the road a similar agreement with the County possibly for the median on Sinclair if we get them to buy in and tie it to the development of the area in general maybe we can bring the West Side entrance up to a closer standard to what we have on the East Side.

Has the deal been closed on the East Side relative to the Interlocal with the County?

Mr. d'Adesky: It is on track. We sent them the form of an Interlocal agreement and they are still debating how they are going to budget it.

Mr. Greenstein: Once we get that deal struck let some time go by and we will hit them up on the West Side.
